### Highlights

Release v3.1.25207 of the Zebra Provisioning Manager is now available for customer access. This release contains the following updates.

### New in Zebra Provisioning Manager v3.1.25207

#### Enhanced Grace Period Configuration

The maximum grace period that can be configured under Customer Configuration in Provisioning Manager has been increased to 150 days. The default remains 30 days, however zebra administrators now have the flexibility to extend the grace period to 150 days to better accommodate customer license requirements.

- Bootstrapping is supported with the following client versions:

PTT Pro Android	3.3.10257
Profile Client	2.0.23401

- Feature-based licensing as provided by the Provisioning Manager is first supported in Zebra Voice v9.0.20306. The customer may view the licensed devices in the Provisioning Manager portal, in the Licensing/Assigned tab.
- The customer may release standard licenses from specific devices by obsoleting them in the Extension Manager portal, in the Portal/Devices tab.
- **Important:** Note that premium licenses can only be used for premium PBXs. Standard PBXs require standard licenses. Customer with premium licenses should ensure that their devices are all configured to use premium PBXs.
- Licensing notes:
  - Existing 9.x customers upgrading to Zebra Voice v9.0.20306 must contact Zebra to enable the migration of their current licenses to AID-free licensing.

- Licenses for the Zebra Voice Client 9.x may include a 30-day grace period. The client will display the expiration date including the 30-day grace period, but any renewals will be based off the actual expiration date. Refer to your entitlement email from Zebra Onboarding for your actual expiration date.
- 3<sup>rd</sup> party device support for stand-alone clients requires the following client versions:
  - Zebra-Voice v9.0.22308 or above (Zebra Voice is not supported on iOS devices)
  - PTT Pro Android v3.3.10197 or above
  - PTT Pro iOS v1.0.11086 or above
