

## Saudi Arabia Privacy Statement

This Saudi Arabia Privacy Statement supplements the Zebra Privacy Policy to the extent the Kingdom of Saudi Arabia's ("**KSA**") Personal Data Protection Law ("**KSA PDPL**") is applicable to you.

### DATA ZEBRA COLLECTS

To the extent possible, Zebra will only collect personal data directly from you, unless otherwise permitted by applicable law.

The information that Zebra collects from you is required for the provision of products or services to you. Unless otherwise specified, it is required for Zebra to collect and process all the personal data described in Zebra's Privacy Policy. A failure to provide Zebra with certain information (including personal data) may result in your inability to effectively use Zebra's website and may impact Zebra's ability to provide any products and services to you.

### CROSSBORDER TRANSFER OF PERSONAL DATA

In certain instances, your personal data will be transferred outside of KSA to Zebra affiliates and third parties located abroad. In such instances, all transfers will be in accordance with the KSA PDPL, including the employment of acceptable safeguards, where required.

### DATA SUBJECT RIGHTS

You have the following rights in relation to Zebra's processing of your personal data:

- To be informed about the legal basis and the purpose of the processing of your personal data;
- To access your personal data processed by Zebra, without prejudice to applicable laws;
- To obtain copies of your personal data processed by Zebra, in accordance with applicable laws;
- To request correction, completion, or updates to your personal data processed by Zebra; and
- To request the destruction of your personal data processed by Zebra, in accordance with applicable laws.

### CHANGES TO SAUDI ARABIA STATEMENT

Zebra reserves the right to change the Saudi Arabia Privacy Statement and the Zebra Privacy Policy from time to time. Any changes that Zebra may make to these policies will be posted on Zebra's website and will be effective from the date of posting.
