

TURKEY PRIVACY STATEMENT

This Turkey Privacy Statement supplements the Zebra Privacy Statement to the extent you use our website and the Turkish Data Protection Law numbered 6698 (“TDPL”) to you.

LEGAL BASES

Your personal data are processed in accordance with the legal bases set out in Article 5 of TDPL. Your data stated in the Zebra Privacy Statement are processed in accordance with subparagraph (c) “processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract”, subparagraph (ç) “it is necessary for compliance with a legal obligation to which the data controller is subject” and subparagraph (f) “processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject” of paragraph 2 of Article 5 of TDPL.

CROSSBORDER TRANSFER OF PERSONAL DATA

Your personal data will be transferred to Zebra affiliates located abroad based on your explicit consent in accordance with Article 9 of the TDPL due to Zebra being an international company. You can find detailed information on crossborder transfer in the “Customer Explicit Consent Form Regarding the Crossborder Transfer of Personal Data”. The Zebra affiliates include Zebra Technologies Europe Limited, Zebra Technologies Corporation in the United States, Zebra Teknolojileri Sisteem Cozumleri Anonim Sirketi in the Republic of Türkiye and any other Zebra affiliates as necessary.

YOUR RIGHTS AS DATA SUBJECTS

Regarding your personal data as a data subject located in Turkey, you have the following rights according to Article 11 of TDPL:

- to learn whether your personal data are processed or not,
- If your personal data are processed, to request information thereabout,
- to learn the purpose of the processing of your personal data, and whether these personal data are then used for the intended purposes or not,
- to learn the identity of third parties to whom your personal data are transferred within country or abroad,
- to request the rectification of the incomplete or inaccurate data, if any,
- to request the erasure or destruction of your personal data within the frame of the terms and conditions specified in TDPL,
- If you request completion or correction of incomplete or inaccurate data, or erasure or destruction of your personal data, to request that this situation be notified to the third parties to whom we transfer your personal data,
- to object to the emergence of a result against the person her/himself due to analyzing the processed data exclusively through automatic systems,
- to request compensation for the damage arising from the unlawful processing of your personal data.
