

## INDEPENDENT LIMITED ASSURANCE STATEMENT



**To: The Stakeholders of Zebra Technologies Corporation**

### Introduction and objectives of work

Apex Companies LLC (Apex) has been engaged by Zebra Technologies Corporation (Zebra) to provide limited assurance of select environmental data to be incorporated into its external corporate reporting activities. This independent assurance statement applies to the related information included within the scope of work described below.

This information and its presentation are the sole responsibility of the management of Zebra. Our sole responsibility was to provide independent assurance on the accuracy of information included.

### Scope of work

The scope of our work was limited to assurance over the specific data presented below for the period January 1, 2025 to December 31, 2025 (the 'Subject Matter'). Our assurance does not extend to any other information reported by Zebra.

Zebra requested Apex to provide assurance of the following:

- Total water withdrawal<sup>1</sup>

As part of the scope of work, Apex reviewed and evaluated the following:

- Appropriateness and robustness of underlying reporting systems and processes used to collect, analyse, and review the reported environmental information; and
- Evaluation of the reported data against Zebra's internal reporting procedures.

### Reporting Boundaries

The following are the boundaries used by Zebra for reporting sustainability data:

- Operational Control
- Worldwide Operations

### Limitations and Exclusions

Excluded from the scope of our work is any assurance of information relating to:

- Activities outside the defined assurance period; and
- Water consumption at locations where Zebra does not receive actual water consumption data.

This limited assurance engagement relies on a risk-based selected sample of sustainability data and the associated limitations that this entails. The reliability of the reported data is dependent on the accuracy of metering and other measurement arrangements employed at site level, not addressed as part of this assurance. This independent assurance statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

<sup>1</sup> The total water withdrawal includes data from 24 of Zebra's 131 locations. These 24 locations make up 63% of Zebra's physical footprint.



## Responsibilities

This preparation and presentation of the data are the sole responsibility of the management of Zebra. Apex was not involved in the development, tracking, or reporting of the environmental sustainability data. Our responsibilities were to:

- obtain limited assurance about whether the Subject Matter has been prepared in accordance with the Reporting Criteria;
- form an independent conclusion based on the assurance procedures performed and evidence obtained; and
- report our conclusions to the Stakeholders of Zebra.

## Assessment Standards

We performed our work in accordance with Apex's standard procedures and guidelines for external Assurance of Sustainability Reports and International Standard on Assurance Engagements (ISAE) 3000 Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information (effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and Assurance Standards Board. A materiality threshold of  $\pm 5$ -percent was set for the assurance process.

## Summary of Work Performed

As part of our independent assurance, our work included:

1. Assessing the appropriateness of the Reporting Criteria for the Subject Matter;
2. Conducting interviews with relevant personnel of Zebra;
3. Reviewing the data collection and consolidation processes used to compile Subject Matter, including assessing assumptions made, and the data scope and reporting boundaries;
4. Reviewing documentary evidence provided by Zebra;
5. Agreeing a selection of the Subject Matter to the corresponding source documentation;
6. Reviewing Zebra systems for quantitative data aggregation and analysis; and,
7. Assessing the disclosure and presentation of the Subject Matter to ensure consistency with assured information.
