

Regulatory Information

This device is approved under Zebra Technologies Corporation.

For use only with Zebra approved and UL Listed mobile computers, Zebra approved, and UL Listed/Recognized battery packs.



CAUTION: Only use Zebra approved and UL Listed accessories, battery packs, and battery chargers. Do NOT attempt to charge damp/wet mobile computers or batteries. All components must be dry before connecting to an external power source.

Declared maximum operating temperature: 50°C.

Power Supply

Use ONLY a Zebra approved UL LISTED ITE (IEC/EN 60950-1, LPS/SELV) power supply with electrical ratings as follows: Output 12 VDC, min 4.6 A for SHARECRADLE-01. Output 12 VDC, min 9 A for SHARECRADLE-02, SHARECRADLE-MC and SHARECRADLE-ME with a maximum ambient temperature of at least 50 °C. Use of alternative power supply will invalidate any approvals given to this unit and may be dangerous.

Batteries

Use only Zebra approved batteries. Accessories which have battery charging capability are approved for use with the following battery models:

Part Number: BTRY-TC8X-67MA1-01 (4.2 VDC, 6700 mAh)

Part Number: BTRY-TC8X-70MA1-01 (4.2 VDC, 7000 mAh).

Zebra approved rechargeable battery packs are designed and constructed to the highest standards within the industry.

However, there are limitations as to how long a battery can operate or be stored before needing replacement. Many factors affect the actual life cycle of a battery pack such as heat, cold, harsh environmental conditions, and severe drops.

When batteries are stored over six months, some irreversible deterioration in overall battery quality may occur. Store batteries at half of full charge in a dry, cool place, removed from the equipment to prevent loss of capacity, rusting of metallic parts, and electrolyte leakage. When storing batteries for one year or longer, the charge level should be verified at least once a year and charged to half of full charge.

Replace the battery when a significant loss of run time is detected.

Battery Safety Guidelines

The area in which the units are charged should be clear of debris and combustible materials or chemicals. Particular care should be taken where the device is charged in a non-commercial environment.

- Follow battery usage, storage, and charging guidelines found in the user guide.
- Improper battery use may result in a fire, explosion, or other hazard.

- To charge the mobile device battery, the battery and charger temperatures must be between +32 °F and +104 °F (0 °C and +40 °C).
- Do not use incompatible batteries and chargers. Use of an incompatible battery or charger may present a risk of fire, explosion, leakage, or other hazard. If you have any questions about the compatibility of a battery or a charger, contact Zebra support.
- Do not disassemble or open, crush, bend or deform, puncture, or shred.
- Severe impact from dropping any battery-operated device on a hard surface could cause the battery to overheat.
- Do not short circuit a battery or allow metallic or conductive objects to contact the battery terminals.
- Do not modify or remanufacture, attempt to insert foreign objects into the battery, immerse or expose to water or other liquids, or expose to fire, explosion, or other hazard.
- Do not leave or store the equipment in or near areas that might get very hot, such as in a parked vehicle or near a radiator or other heat source. Do not place battery into a microwave oven or dryer.
- Battery usage by children should be supervised.

- Please follow local regulations to promptly dispose of used rechargeable batteries.
- Do not dispose of batteries in fire.
- Seek medical advice immediately if a battery has been swallowed.
