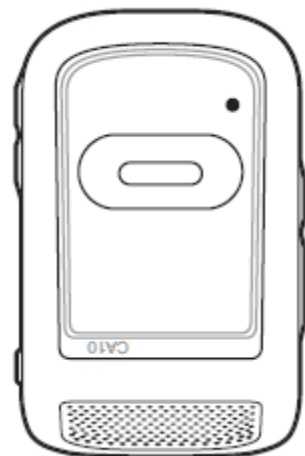
## Power Supply

## Batteries
